The Kern Behavioral Health and Recovery Services Family Advocate provides assistance to family members and support persons of individuals with mental illness, and/or substance abuse.

Our focus is to empower the family members through advocacy, education, and linkage to family centered resources.

## The Family Advocate can:

- Encourage family involvement and participation in treatment direction or discussion, as well as partnership of client and mental health services facilitating the pursuit of wellness, recovery, and resilience.
- Educate treatment providers and families regarding mental health law, community support and mental health resources, engagement and integration strategies for family members in the recovery process.
- Serve as a liaison between service providers and the family or support person.
- Assist families and team members with navigating the mental health system
  of care.
- Advocate for family as a group within the mental health system, identifying and bridging gaps in services, as well as facilitating improved communication with service providers.
- Represent family members interest on county and state-wide taskforces.
- Maintain collaborative relationships with family support groups and family resources, such as NAMI (National Alliance on Mental Illness).
- Identify safety concerns posed by belonging to a family affected by mental illness.
- Receive and resolve family complaints and concerns regarding mental health services in Kern County.
- Encourage families to join the National Alliance on Mental Illness (NAMI).
- Provide written resources and referral to community resources available to help family members to cope and gain helpful information.

## **The Family Advocate cannot:**

- Provide therapy services needed by an individual or by family members.
- Release confidential information to family members without the client's consent
- Make decisions for family members.
- Force a family member receiving services to do anything against his or her will.
