

# SERVICES

The Homeless Program is an intensive, short-term case management program which targets adults 18-years old and older, who are homeless with a chronic and persistent major mental illness or dual diagnosis (mental health primary disorder and a secondary substance abuse disorder). Financial requirement: Indigent / no payor source. Case Managers assist individuals in obtaining services for mental health, medical, legal, financial, housing, daily living skills and various community support services. Once stabilized and permanent financial resources are obtained, individuals if appropriate, are then transferred to the geographic appropriate team that provides long-term case management services. Transitional housing is provided that include Board & Care, Room & Board. Motels or Specialty Transitional Housing facilities. Access points in the System of Care are ACCESS and KMC 3B. Individuals who have improved and require no case management services may be transitioned to a mini-clinic or lower level of care.

# ADMISSION

# ADMISSION



### ELIGIBILITY

To qualify for help, applicants must be chronically mentally ill and homeless or at serious risk of becoming homeless. They must also be adults 18 to 65 years old and willing to accept services.
